4. BSL will provide user name and initial password for Mobile apps facilities through the trading system DSE FlexTP provided by DSE.
5. Password policy of mobile apps i.e. uppercase, lowercase, symbol and number (example: Ab@1).
6. BSL will have full right to deduct service charge for Mobile apps facilities from the customer account as decided the Management of the company.
7. Each sale order shall be executed in presence of saleable shares/securities in the client's Portfolio Account.
8. Each buy order shall be executed against the available purchase power only.
9. For any problem client at the initial time, like login problem, order submission problem and others client will be communicate with BSL IT .
10. For any wrong information regarding buy/sale of securities, the client shall have full liability for the same.
11. If the required fund to buy does not available in the client's accounts Mobile apps will not be bound to buy against the intension of the Client(s).
12. If there has any manipulation in any order, trader will not be liable for the same.
